On January 4, 2024, Boyd B. Chumbley, President of the Culp Upholstery Fabrics division, notified the company of his intention to retire from his position in the third quarter of the calendar 2024 year, with the definitive date of such retirement still to be determined. He will remain in his position as President of Culp Upholstery Fabrics until such date, and will thereafter continue in an advisory role as needed to strategically support the company.

CULP ANNOUNCES LEADERSHIP ADDITION AT CULP UPHOLSTERY FABRICS, ALONG WITH PLANNED TRANSITION FOR DIVISION PRESIDENT BOYD CHUMBLEY

HIGH POINT, N.C. (January 8, 2024) – Culp, Inc. (NYSE: CULP) (together with its consolidated subsidiaries, "CULP") today announced that Mary Beth Hunsberger will be joining the company as Executive Vice President of Culp Upholstery Fabrics, effective January 8, 2024. He has served as a dedicated leader throughout his tenure and plans to transition to a supporting role in the third quarter of the calendar 2024 year. In this new role, he will continue adding significant strategic value with his experience and extensive knowledge of the home furnishings industry.

Commenting on the announcement, Iv Culp said, "Boyd has been with Culp Upholstery Fabrics for 40 years, and we are extremely grateful for his loyalty and sound leadership. He has a passion for steady business models and high-functioning supply chains in a global environment.
